



Attleboro Community Electricity Aggregation Program

Dear Attleboro Electricity Customer,

The City of Attleboro is offering Attleboro Community Electricity Aggregation (Attleboro CEA), which provides new City-vetted options for electricity supply. National Grid will continue to deliver your electricity, however, the electricity supplier was chosen by the City of Attleboro through a competitive bid process that leveraged the bulk-buying power of our community, understanding that savings cannot be guaranteed.

You will be automatically enrolled in the Attleboro CEA product, “Attleboro Standard,” as of your March 2024 electricity meter read, unless you choose one of our optional products or choose to opt out.

To opt out and avoid automatic enrollment in the Attleboro CEA Program, you must do one of the following before February 19, 2024:

 **mail and postmark the enclosed opt-out card** OR  **call Constellation at (833) 461-0813** OR  **submit the opt-out form at MassCEA.com/Attleboro**

Participants may also opt out of Attleboro Community Electricity Aggregation at any time during the Program without penalty. Please read further to learn more about Attleboro Community Electricity Aggregation.

ATTLEBORO CEA GOALS



Competitive and Stable Prices

All Attleboro CEA prices are fixed through November 2025, whereas National Grid Basic Service prices change every nine months for Residential and Commercial customers, and every three months for Large Commercial and Industrial customers. Attleboro CEA offers options that are intended to be price-competitive with National Grid Basic Service, however, **savings cannot be guaranteed**. This is because Basic Service rates are not known for the entire period of Attleboro’s contract, and may therefore be above or below Attleboro CEA rates in any given period.



No Obligation

Attleboro CEA includes the ability to leave the Program at any time without penalty.



Electricity Choice

Attleboro CEA offers two different electricity supply choices with different levels of renewable energy certificates (RECs) to match your budget and climate goals.

ATTLEBORO CEA PRODUCTS

Standard Product



Attleboro Standard: This is the **standard product** that you will be automatically enrolled in if you do nothing. The goal for this product is to be equal to, or lower than, the average National Grid Basic Service rates over Attleboro’s contract term. However, as Basic Service rates change, **savings cannot be guaranteed** for any given period.

Other Products

Attleboro CEA also offers an optional electricity product with a different amount of RECs relative to mandated requirements. To enroll in this optional product, you must contact the supplier, **Constellation**, at (833) 461-0813, or sign up on the program website: MassCEA.com/Attleboro.



Attleboro Plus: This is an **optional product**. It adds Renewable Energy Certificates (MA Class I RECs) to the renewable energy standards set by the Commonwealth to total one hundred percent (100%) of a customer's electricity consumption.

ATTLEBORO CEA PARTICIPATION

To enroll in the Attleboro Community Electricity Aggregation Standard product, you do not need to take any action. To enroll in an optional Attleboro CEA product, contact the supplier, Constellation, or use the online form at MassCEA.com/Attleboro. If you don't wish to participate, mail and postmark the enclosed opt-out card on or before **February 19, 2024** to avoid automatic enrollment in the Attleboro CEA Program.

Budget Plan or Eligible Low-Income delivery rate consumers will continue to receive those benefits from National Grid.

Solar Electricity Consumers will not be impacted and will continue to receive their net metering credits while participating in the Program.

Exit Terms for Basic Service: There is no penalty charge for leaving National Grid's Basic Service, however, Industrial customers (G-2 and G-3) may receive a reconciliation charge or credit. If you have already chosen a Green Power supply option on your own, you must opt out of this Program. This will ensure you continue to receive your electricity from that Green Power Supply.

You can leave the Program any time after you've enrolled, with no early termination fees. If you leave the Program, your account(s) will be returned to National Grid's Basic Service on the next available meter read.

If you are receiving electricity supply from a competitive supplier and believe you have received this opt-out letter in error, you must sign and return the enclosed opt-out card. This will ensure you continue to receive your electricity from that competitive supplier and prevent any possible early termination fees.

Tax-exempt small business customers must provide a copy of their Energy Exemption Certificate directly to Constellation via email at CNETaxForms@constellation.com, fax at (877) 243-4968, or mail at Attn: Tax Team, 1001 Louisiana Street, Suite 2300, Houston, TX 77002, in order to maintain their tax-exempt status.
